Analýza trendů kriminality v České republice v roce 2019 Analysis of Trends in Criminality in the Czech Republic in 2019 Scheinost, M. (Ed.)

The publication is based on statistical data from judicial (courts, public prosecutor's offices), police and prison service sources, statistical data from the Probation and Mediation Service, crime prevention data from the Czech Ministry of the Interior, and data on criminality of foreigners and migration (source: Police of the Czech Republic). Selected data from public opinion polls on crime prevention and other issues, repeatedly carried out by the ICSP in cooperation with the Ministry of the Interior of the Czech Republic and data obtained from surveys conducted by the Centre for Public Opinion Research was also used. In addition to the above data, another source for analysis was information obtained from the ICSP's own research and studies and the expert opinions of contacted experts from the Police of the Czech Republic and the judiciary. In addition to gathering and processing available data on the state and development of crime and criminal policy, the analysis includes comments on development trends, along with an outline of possible factors affecting these trends.



Kyberkriminalita v kriminologické perspektivě Cybercrime from a Criminological Perspective Vlach, J., Kudrlová, K., Paloušová, V.

The development of information and communication technologies and the expansion of their use has given rise to new forms of crime, while traditional forms of crime have also embraced these new technologies. The publication presents research findings examining selected areas of cybercrime, so-called computer crimes in particular (section 230-232 of the Criminal Code). The results are mainly based on an analysis of criminal files, which includes several thematic areas examined in more detail. The publication also includes selected findings of a study of foreign and domestic professional literature and relevant documents, an analysis of legislation and relevant case law, available statistical data, as well as consultations with several experts. The authors also inform about ongoing survey focused on czech internet users' experience with selected phenomenons online.

The monograph summarizes the main findings of a study examining the issue of probation officers' reports prior to a decision on the imposition of an alternative sentence, which serves as the basis for their effective imposition. It summarizes the findings on probation officers' reports regarding the possibility of imposing the sentences of community service or home detention. The publication presents the results of research in the impact of the information contained in these reports on the imposition and successful execution of imposed alternative sentences and the subsequent recidivism of convicted offenders. The publication also presents the results of an analysis of the opinions and views of judges, public prosecutors and probation officers on the issue of these reports. The monograph concludes with recommendations to improve the application and further development of PMS reports prior to a decision on the imposition of a sentence.

Globální studie o pašování migrantů 2018 Global Study on Smuggling of Migrants 2018

The publication presents a Czech translation of a study by the European Institute for Crime Prevention and Control (HEUNI) titled "Crime and Gender: A Study on How Men and Women are Represented in International Crime Statistics". The study examines the representation of men and women in statistics, covering the whole criminal justice process, from police records of suspects to statistics on sentences. The aim was to show the degree of difference in the number/proportion of offenders by gender and to examine the development of these indicators. The study is based on two sources of crime statistics - the Crime Trends Survey conducted by the United Nations Office on Drugs and Crime (UNODC), and the European Sourcebook of Crime and Criminal Justice Statistics.
